CLARIFICATION FOR USING UNIT RESPONSIBILITY ITEMS (UURI)/
ADDITIONAL AUTHORIZATION LIST (AAL) ITEMS STOCKAGE LEVELS

(b) MCO 4400.150

1. This letter supersedes Clarification 4-15: Requisition of Unit Using Responsibility Item (UURI) Materiel as listed in reference (a).
2. Effective immediately, the following definition of UURI/AAL supplants the definition contained within reference (b):

Using Unit Responsibility Items/Additional Authorized List (UURI/AAL). These are items that are not issued with end items during initial provisioning and subsequent fielding. Items in this category must be requisitioned by the using unit, not to exceed the stated quantity. The CO may authorize, in writing, to hold less than the stated quantity if the item does not meet the criteria stated in paragraph 17.b(3)(a). Additionally, where "AR" (as required) is the stated quantity, the CO must establish, in writing, the authorized quantity to be held by the command. If the item with "AR" is not included in the CO's authorization, then the "AR" quantity to be held is 0. These quantities will be reviewed and updated at least annually.

3. This updated definition will be included within a forthcoming revision to consumer-level supply policy.
